Job Summary: A CT Technologist is a highly skilled professional who uses specialized computerized X-ray equipment to produce cross-sectional images of human anatomy, which aid radiologists in diagnosing a wide variety of diseases and disorders.

Minimum Qualifications:

- CT Technologist certified
- Satisfactory completion of formal Radiologic technology training in an approved school and the ability to meet requirements for registry by the American Registry of Radiologic Technologists (ARRT)

- Ability to communicate clearly in both oral and written forms using the English language.
- Ability to respond to common inquiries or complaints from residents, patients, physicians, peers, regulatory agencies, or members of the business community.

Lifting Requirements

Heavy lifting: up to 100 lbs. maximum with frequent lifting and/or carrying objects weighing up to 50 lbs. Must be able to stand, stop, lift, and walk without restrictions.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Operate head or body x-ray scanners, which create a computer-generated cross-sectional image, commonly called a CAT (Computed Axial Tomography) Scan
- Responsible for educating and preparing patients for their examinations
- Provide patient care that is essential to the performance of a variety of procedures (ie, contrast IV, oral and rectal, and checking GFR for all patients receiving contrast)
- Take the patient's medical history before the exam
- Position patients so desired anatomy will be demonstrated
- Determine and set appropriate technical parameters to accurately demonstrate anatomy and pathology
- Assume responsibility for the safety, mental, and physical comfort of patients.
- Mandatory on call for ER exams or Stat exams, Sunday to Saturday, our facility is 24 hours
- Prepares and maintains records and files as directed (clipboard log, Care Vue, Putty, superbill, orders)

Physical Requirements:

•	Ability to stand for long periods and perform repetitive motions (e.g., pipetting).
•	Sometimes it requires lifting and moving lab equipment (up to 50 lbs.).
•	Physically assist patients onto examination tables, which may involve lifting or repositioning.

• Hold or manipulate imaging equipment that can weigh 25-50 lbs.
